Pierluigi Valsecchi is Professor of the History of Africa in the Department of Political and Social Sciences, University of Pavia. From 2005 to 2008 he was Professor in the Faculty of Communication, University of Teramo, and tenured Researcher in the Faculty of Political Sciences, University of Urbino, from 1993 to 2005. From 1975 to 1985, he studied at the Scuola Normale Superiore di Pisa, first as an undergraduate and later as a doctoral student in History. Between 1986 and 1993 he was in charge of the African section of the Istituto per le relazioni coi paesi dell'Africa, America latina e Medio oriente (Ipalmo), Rome, where he focused in particular on political issues concerning post-colonial African States, development, and the political transition in South Africa. He has been conducting research in Ghana and the Ivory Coast since 1987. His research interests include political and social history (17th-20th century), chieftaincy, elites.
